**FINANCE COMMITTEE (Adamson):** Chip made a motion, seconded by Nick Wunner to approve the 2007-2008 NJSPLS Operating Budget. The motion carried.

**GIS/LIS (Borbas):**

1. Josh Greenfeld had done a study of GIS activities of all 50 states which stemmed from his work at ACSM conferences. This info is in the ACSM BULLETIN.
2. GLIS (NSPS) has a spot for Affiliate Members. Currently there are no State Affiliates of GLIS. Borbas would like NJSPLS to apply to GLIS to become an Affiliate of GLIS and was seeking our approval. A nominal fee might be involved. Nick Wunner made a motion seconded by John Richardson to request that Peter Borbas send a letter of application to GLIS to become an Affiliate Member. The motion carried.
