**APPROVAL OF AGENDA:** The agenda was approved with amendments.

**APPROVAL OF MINUTES:** Charlie Bell made a motion, seconded by Nick Wunner to approve the minutes of the September 2007 Board of Directors meeting. The minutes were approved.

**TREASURER'S REPORT:** Stan Hans made a motion that was seconded to approve the Treasurer's Report that was included in the agenda packet. The motion carried.

**CORRESPONDENCE:** Allan Ritchie has submitted a request for Life Membership in the NJSPLS. Lew Conley made a motion to grant Life Membership status to Allan Ritchie. Nick Wunner seconded the motion. The motion was denied.

**STATE BOARD LIAISON:** Topography issue: The State Board has approved the Special Committee's findings that is scheduled to be published in the NJ Register within the next few months.

**NSPS DELEGATE (Swiderski):** Lobby Day will be held in Washington later this month. ACSM and NSPS financially support ABET. Discussion on settlement map process using old surveys, based on an issue from a firm in the Midwest.

**EXECUTIVE COMMITTEE (Pennell):** Lew Conley chaired the Ad Hoc Committee to review the management contract with Husik & Associates. A renewal has been prepared and was presented to the Board of Directors. The management contract was approved as presented.

**FINANCE COMMITTEE (Adamson):** No report.

**CONFERENCE (Mazurek):** Conference schedule has been finalized. Reminder that award nominations are due with a bio by 10/31/07.

**GIS/LIS (Borbas):** Bill DiBartolo reported for Peter Borbas that the next GIS Committee meeting will be on 9-21 in Washington Crossing, immediately following the 10 AM NJ Geospatial Forum meeting.

1. President Pennell introduced Alan Rissmiller to discuss the Boy Scout Camporee at the Sea Girt Training Center. Volunteers will be laying out the site on 10-4. NJSPLS will also have a tent at the Camporee for the scouts to visit.
2. ROW Request: Pat Fatton discussed an issue that Bruce Blair brought to his attention regarding a PLS who was attempting to obtain data from a GPS point on Interstate 195 and was stopped by the NJ State Police. Fred Czepiga said that one needs to file for a permit with the Regional Office of NJ DOT and that the permit can take 4-6 weeks to process. Lew Conley stated that there is a manual for Uniform Traffic Control Devices which addresses just how work on the state’s highways can be performed. There are also questions on licensing exam from this manual.
3. Fred Czepiga reported Warren Payton’s contact with the NJ DOT as Geodetic Advisor is up in October. The future of this position is uncertain as it is based on budgetary issues. Directors were encouraged to send a letter to NJ DOT (Brian Strizki) in support of this position.
4. Discussion on the possibility of adding another award to the Annual Awards - Business or Corporation of the Year. It was the general consensus of the Board not to add another award at this time.
5. Tom Yager brought up a flyer he received regarding surveying services. It was suggested to him to submit this to the State Board.
